Items include beds, dressers, tables, seating, and kitchen essentials, enabling households moving into housing to create safe, functional living spaces. The program serves people transitioning out of homelessness, survivors of domestic violence, veterans, and low-income households experiencing furniture poverty, often including children. Referrals typically come from social service agencies, with some eligible self-referrals. Annually, HomeAhead assists about 200 households, supporting housing stability by providing essential items many cannot afford. The program also reduces landfill waste by reusing donated furniture.
